TERMS

- I, _____, legal owner of this vehicle do hereby agree to the following terms for consignment.
- ___ Consignment is exclusive for a 90 day period and will remain in effect thereafter until terminated by either party upon giving 15(fifteen) days written notice.
- ___ If the vehicle is removed form PINNACLE COACH prior to the end of the contract period, there will be a penalty of \$1000.00.
- ___ PINNACLE COACH will expect to sale your unit for \$ _____, any amount received over and above said net price will be used by PINNACLE COACH for reimbursement for expenses involved, and as a selling commission. Pinnacle has a \$1,000 minimum commission for a towable and \$2,000 minimum commission for a motorhome.
- ___ PINNACLE COACH will be responsible for all advertising expense on the following: various internet websites including ours, and all print publications displayed or distributed by PINNACLE COACH.
- ___ Consignor will be restricted from advertising the unit, by any means, for the duration of this exclusive agreement. However, consignee may refer prospective buyers to PINNACLE COACH.
- ___ PINNACLE COACH will detail and maintain cleanliness of consignor's unit while under this agreement. Some repairs and maintenance may be necessary; PINNACLE shall provide an estimate of any such services and obtain the owners prior authorization.
- ___ PINNACLE COACH is NOT responsible for any personal items that may be left in the unit and is NOT responsible and will be held harmless for any theft or damage that may occur to said vehicle for sale at their location.
- ___ I further certify that the above described RV has been delivered on consignment to PINNACLE COACH and that said dealership is acting on my authority, solely as a broker, when offering such vehicle for sale at their location.
- ___ Vehicle owner agrees to keep full coverage insurance in effect while vehicle is in the care of PINNACLE COACH. Consignor agrees to defend, indemnify and hold harmless RV Dealer and any of its affiliates, subsidiaries, directors, officers, employees, and agents from against: Any claim for personal injury or property damage which may arise from RV while in use or occupancy of the unit.
- ___ Owner agrees to have at least a half tank of fuel , one-third tank of propane, and have all holding tanks dumped before leaving with PINNACLE COACH. (\$4.00 per gallon for fuel charge will apply and \$75.00 tank dump fee will apply)
- ___ Consignor agrees if the net proceeds be insufficient to discharge all liens and encumbrances, Consignor agrees to pay RV Dealer the difference. Consignor represents and warrants that the vehicle is safe and that the vehicle and its parts are in safe operating condition; with the following exceptions
- ___ Consignor will furnish the following documents to PINNACLE COACH at time of contract:
- ✓ Copy of current registration as proof of ownership of any vehicle for sale under this agreement
 - ✓ Proof of Insurance for any vehicle for sale under this agreement
 - ✓ Copy of current drivers license
 - ✓ Copy of Title and Pay Off if there is any lien against this vehicle
